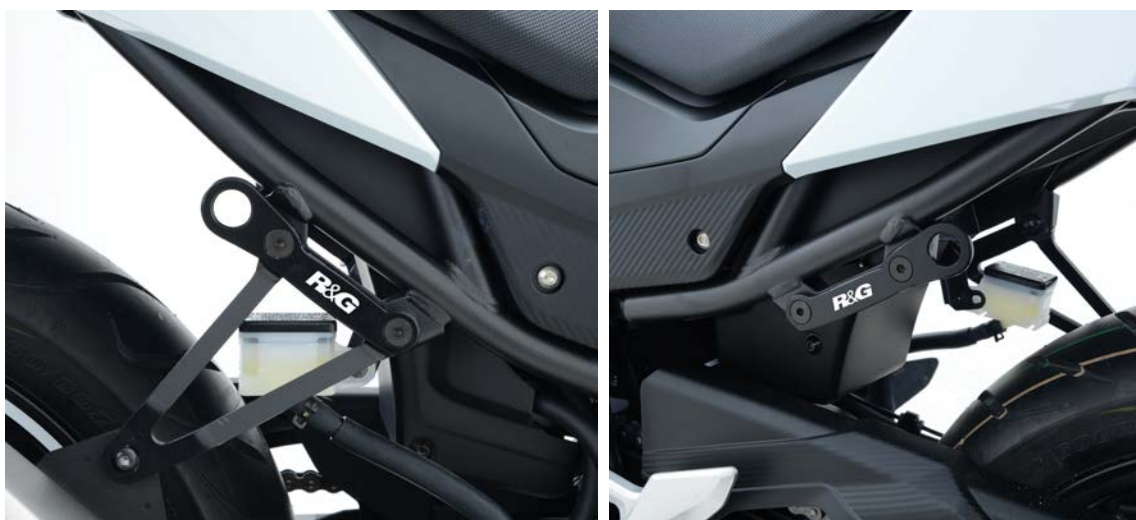




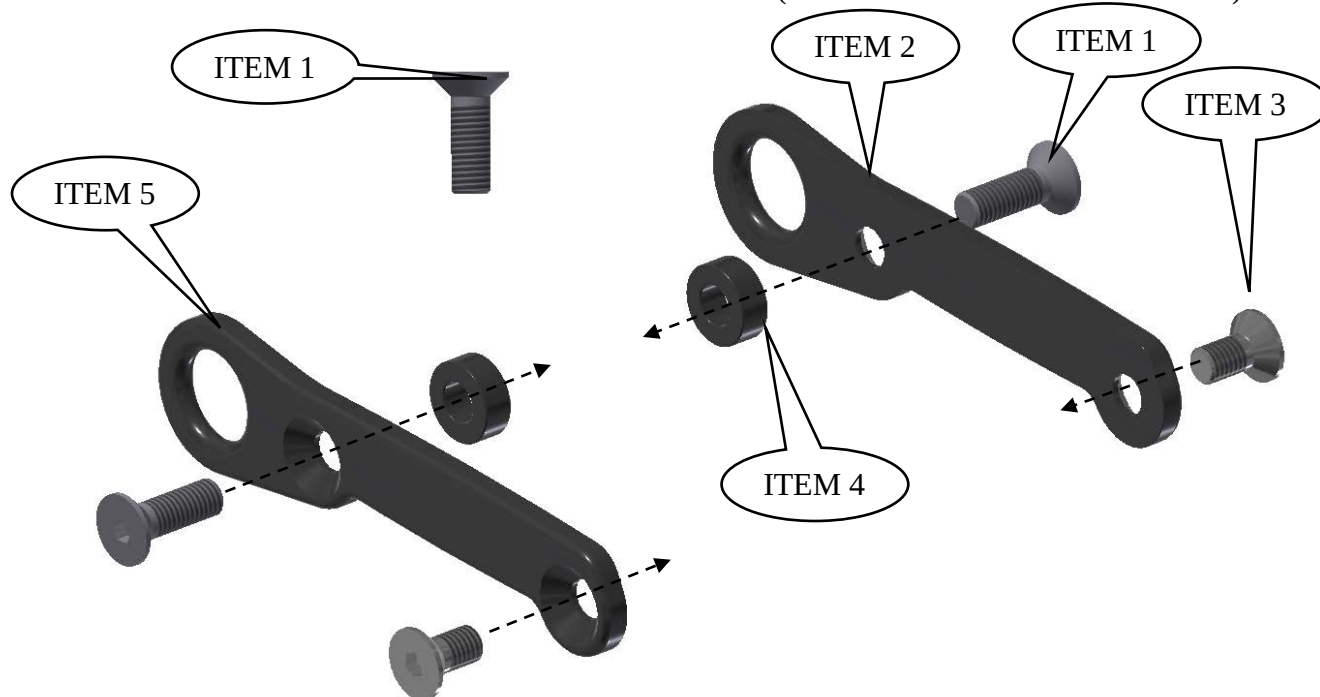
FITTING INSTRUCTIONS FOR TH0008
TRANSPORT HOOKS FOR YAMAHA R25/R3/R320 2014-



THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW.
DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike.

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY).





LEGEND

- ITEM 1 = TIE-DOWN HOOK LEFT HAND SIDE (SMW0064) (x1).
 ITEM 2 = TIE-DOWN HOOK RIGHT HAND SIDE (SMW0065) (x1).
 ITEM 3 = M8 x 15mm LONG COUNTERSUNK BOLTS (x2).
 ITEM 4 = M8 x 25mm LONG COUNTERSUNK BOLTS (x3).
 ITEM 5 = SPACER REAR (S0635=7.5mm WIDE) (x2).

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

TOOLS REQUIRED

- Allen Key set to include 5 & 6mm A/F.

GENERAL TORQUE SETTINGS

M4 BOLT = 8Nm
 M5 BOLT = 12Nm
 M6 BOLT = 15Nm
 M8 BOLT = 20Nm
 M10 BOLT = 40Nm

FITTING INSTRUCTIONS

- Remove the OEM pillion footrests on both sides of the bike.
 - Place one of the longer M8 counter sunk bolts (item 1) through the rear most hole in the left hand side tie-down hook (item 5) and place one of the spacers (item 4) over the exposed thread as shown above.
 - Place one of the shorter M8 counter sunk bolts (item 3) through the forward hole in the left hand side tie-down hook (item 5) as shown above.
 - Offer the assembly into position and tighten into the thread on the subframe.
 - On the right hand side, the transport hook can only be fitted when the original exhaust hanger bracket is not fitted or when an R&G exhaust hanger is fitted, available separately (part No EH0063).
 - With the R&G Exhaust Hanger fitted, remove the two top bolts that mount the hanger to the subframe.
 - Offer the right hand side R&G transport hook (item 2) with the remaining spacer (item 4) into position on the bike and tighten into the thread on the subframe using the two remaining M8 x 25mm long countersunk bolts (item 1) as shown above.
 - If the R&G exhaust hanger is not fitted use one of the shorter M8 counter sunk bolts and one of the longer M8 counter sunk bolts with the spacer.
 - Ensure the part is correctly fitted before tightening all bolts to the recommended torque values.
- We recommend that fabric from the straps be in contact with the product, as opposed to the hook on the end of the strap. This will increase the lifespan of the protective coating on the product.
- Do not overtighten straps attached to the product, as it would be possible to bend or break the product with excessive force. If in any doubt please consult a professional.
- R&G cannot be held liable for any breakages to straps, or consequential damage from this, as a result of fraying/breaking of the straps, or incorrect use. Please ensure that all bodywork of the motorcycle which may come in contact with the straps (e.g. plastic panels, exhausts, swingarms) are protected or left completely clear of the straps.



- While we may show certain applications where the product is being used for attaching luggage to a motorcycle, this is not a general recommendation and cannot be achieved on all motorcycles.

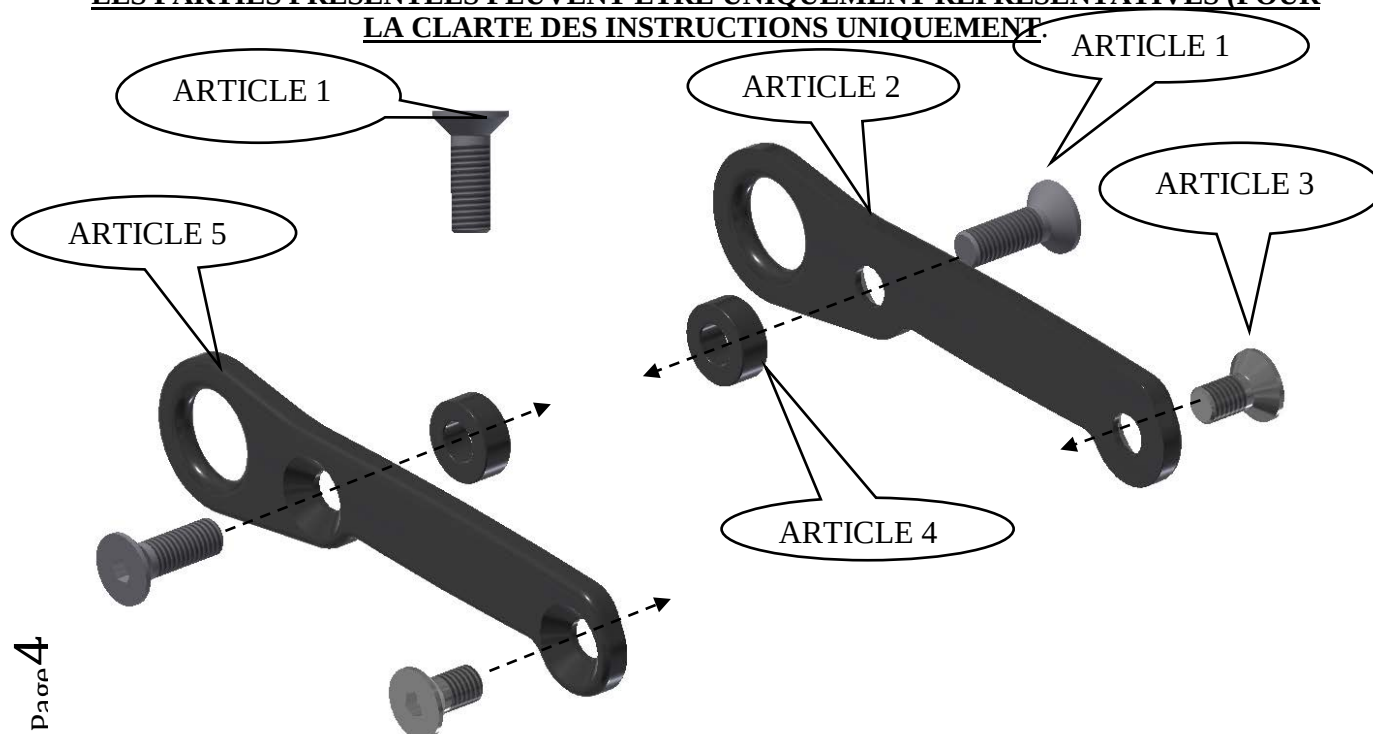

ARTICLE 2 = ATTACHE DE TRANSPORT COTE DROIT (SMW0065) (x1).

ARTICLE 3 = M8 x 15mm BOULONS (x2).

ARTICLE 4 = M8 x 25mm BOULONS (x3).

ARTICLE 5 = ENTRETOISE ARRIERE (S0635=7.5mm DE LARGE) (x2).

NOTICE DE MONTAGE

- Enlever les repose pieds d'origine des 2 cotés de la moto.
 - Placer un des boulons M8 (article 1) dans le trou le plus à l'arrière du crochet d'arrimage gauche (article 5) et placer une des entretoises (article 4) sur le filetage exposé, voir ci-dessus.
 - Placer un des boulons M8 (article 3) dans le trou le plus à l'avant du crochet d'arrimage du coté gauche (article 5) voir ci-dessus.
 - Monter l'ensemble en position puis serrer dans le filetage du sous-cadre.
 - Du coté droit, l'attache de transport ne peut être montée que lorsque le support d'échappement d'origine est retiré ou lorsqu'un support R&G est monté, disponible séparément (partie No EH0063).
 - Avec le support d'échappement R&G monté, enlever les 2 boulons supérieurs qui fixent le support au sous-cadre.
 - Monter l'attache de transport R&G du coté droit (article 2) avec l'entretoise restante (article 4) en position sur la moto puis serrer dans le filetage du sous-cadre en utilisant les 2 boulons restants M8 x 25mm (article 1) voir ci-dessus.
 - Si le support d'échappement R&G n'est pas monté, utiliser un des boulons M8 les plus courts et un des boulons M8 les plus longs avec l'entretoise.
 - Veiller à ce que le produit soit correctement monté avant de serrer tous les boulons aux valeurs de serrage recommandées.
- Nous recommandons que le tissu des sangles soit en contact avec le produit, Par opposition au crochet sur l'extrémité de la sangle. Cela augmente la durée de vie du revêtement protecteur présent sur le produit.



- Ne pas trop serrer les sangles attachées au produit, car cela pourrait plier ou casser le produit avec si la force est excessive. En cas de doute, consulter un professionnel.
- R & G ne peut être tenu pour responsable des bris de sangles, ou des dommages consécutifs à cela, en raison de l'effilochage / rupture des sangles, ou de l'utilisation incorrecte. Veillez à ce qu'aucune partie de la moto ne puisse entrer en contact avec les sangles (par exemple les panneaux en plastique, les échappements, les bras oscillants) et soit protégée ou laissée complètement à l'écart des sangles.
