



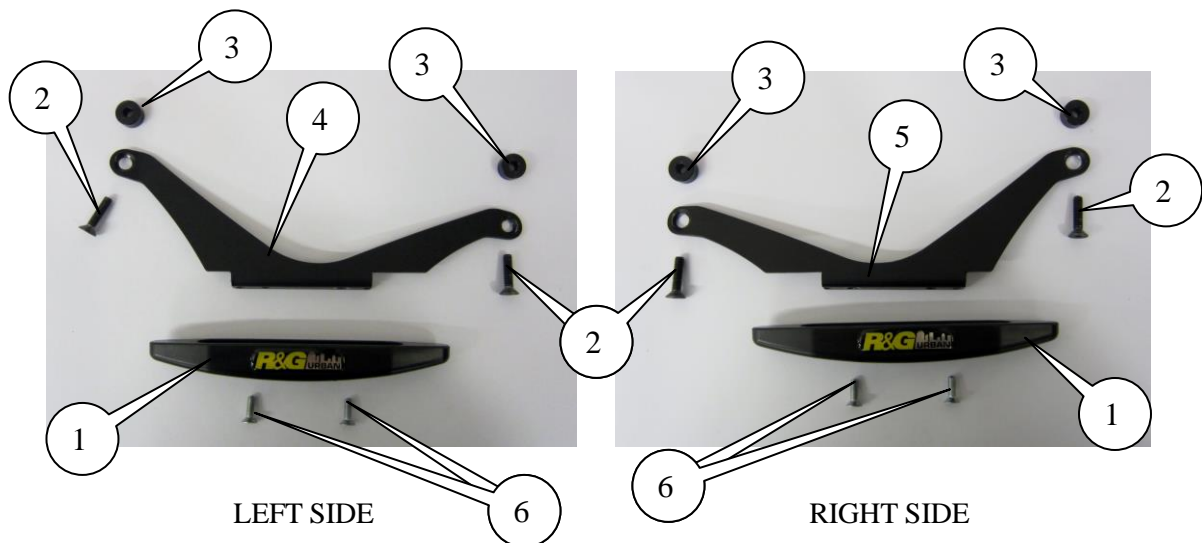
**FITTING INSTRUCTIONS FOR TP0017 FOOTBOARD SLIDERS**  
**HONDA NSC50R 2013**



**THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW.**  
**DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.**

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike.

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)





### **LEGEND**

ITEM 1 = SLIDER (SL0008) (x2).

ITEM 2 = M6x25mm LONG COUNTERSUNK BOLTS (x4).

ITEM 3 = SPACER (S0209) 8mm LONG (x4).

ITEM 4 = MOUNTING PLATE LEFT SIDE (MP0045) (x1).

ITEM 5 = MOUNTING PLATE RIGHT SIDE (MP0046) (x1).

ITEM 6 = M5x12mm LONG COUNTERSUNK BOLTS (x4).

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

### **TOOLS REQUIRED**

- Set of metric Allen keys to include 3 & 4mm A/F sizes.
- 10mm Socket and wrench.

### **FITTING INSTRUCTIONS**

- Take the left side mounting plate (item 4) and fit the slider (item 1) using two of the M5 countersunk bolts (item 6). Fit the bolts through the slider and screw into the mounting plate and tighten, as shown in picture 1.
- Remove the two bolts from the footboard, as shown in picture 1.
- Locate two spacers (item 3 – S0209 – 8mm long) where the two bolts have been removed from, as shown in picture 3.
- Offer the R&G footboard slider assembly into position and insert the M6 x 25mm long countersunk bolts (item 2) through the mounting plate and spacers, before tightening evenly, as shown in picture 4.
- To fit the right side, follow the same procedure as above, using the right side mounting plate (item 5).

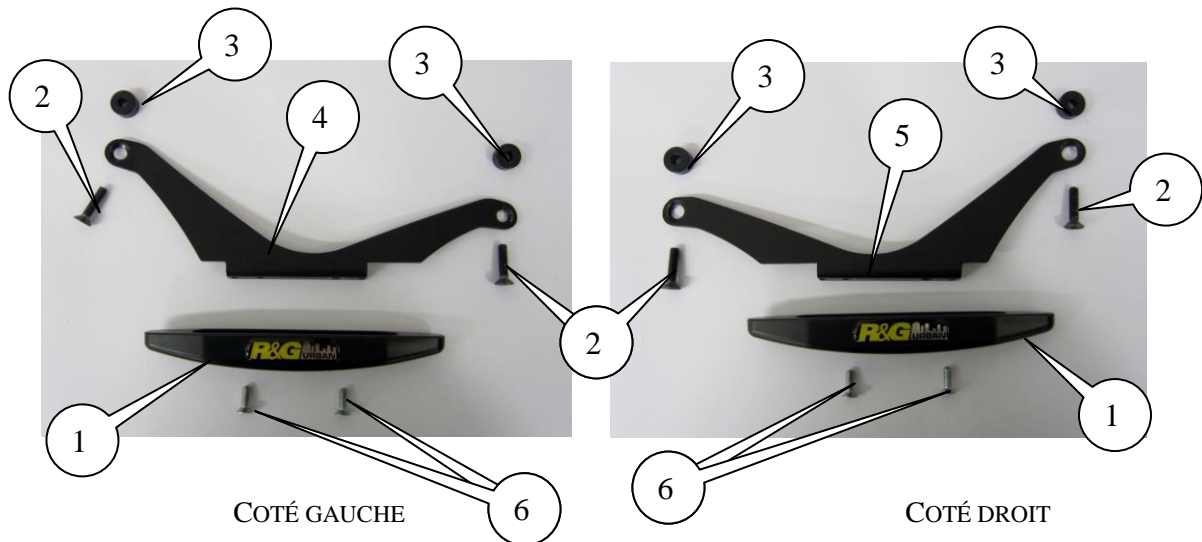

### **Instructions de montage:**

- Prendre la plaque de montage coté gauche (Article 4) et installer le slider (Article 1) en utilisant 2 des boulons M5 (Article 6). Insérez les boulons à travers le slider et visser dans le support de montage puis serrer (Photo 1).
- Enlevez les 2 boulons du marche pied (Photo 1).
- Placer 2 entretoises (Article 3 – S0209 – 8mm de long) où les 2 boulons ont été enlevés (Photo 3).
- Monter l'assemblage de slider marche pied R&G en position et insérer les boulons M6 x 25mm (Article 2) dans la plaque de montage et les entretoises, avant de serrer de façon égale (Photo 4).
- Pour le coté droit, suivez la même procédure que ci dessus, en utilisant le support de montage coté droit (Article 5).
