



Fitting Instructions for RAD0093 Radiator Guard SUZUKI GSX1250FA 2010

In This Kit There Should Be 1x Radiator Guard (RAD0093) 2x 100mm Lengths of Foam

- To fit the radiator guard to the bike cut the foam strip provided into 10mm wide pieces and stick them to the back of the radiator guard frame, so that they sit between the radiator guard and the radiator.
- Remove the three top radiator-mounting bolts in position arrowed in pictures 1 and 2.
- Remove the bottom radiator-mounting bolt in position arrowed in picture 3.
- Fit the radiator guard and secure to top mounting brackets using original bolts as shown in pictures 1 and 2.
- Secure to bottom mounting bracket in position arrowed in picture 3 using original bolt.





<u>Ce kit contient</u> 1x Grille radiateur (RAD0093) 2x 100mm Longeurs de mousse

- Couper la bande en mousse fourni sur 10mm de large et ainsi que des morceaux pour les coller à l'arrière du châssis protège-radiateur, afin qu'elles se placent entre la grille radiateur et le radiateur.
- Retirer les trois premiers boulons en position fléché en images 1 et 2.
- Enlever la vis de fixation comme sur l'image 3.
- Monter la grille radiateur et sécuriser en utilisant les boulons d'origine comme indiqué sur l'image 1 et 2.
- Fixer comme sur l'image 3 en utilisant le boulon d'origine.





<u>Dieser Kit enthält</u> 1x Kühlerschutz (RAD0093) 2x 100mm Schaumstoffstreifen

- Um den Kühlerschutz am Motorrad zu montieren, schneiden Sie zuerst die mitgelieferten Schaumstoff-Streifen in 10 mm breiten Streifen und kleben Sie diese auf der Rückseite des Kühlerschutzrahmens, so dass sie zwischen dem Kühlerschutz und dem Kühler angebracht sind.
- Entfernen Sie die drei oberen Montageschrauben für den Kühler (siehe Abbildungen 1 und 2).
- Entfernen Sie die untere Montageschraube am Kühler (siehe Abbildung 3).
- Montieren Sie den Kühlerschutz und befestigen Sie ihn mit den Originalschrauben an den oberen Montagehaltern (wie in Abbildungen 1 und 2 abgebildet).
- Fixieren Sie den unteren Halter in Position mittels der Originalschraube (siehe Abbildung 3).
